



PARENTAL CONSENT, RELEASE, INDEMNITY, AND HOLD HARMLESS AGREEMENT (Use of Swimming Pool & Participation in Swim Lessons)

This Agreement is made and entered into by the undersigned Parent/Legal Guardian of the child named below ("Child"), in favor of St. George International School (formerly Capital Renaissance International School), a Louisiana nonprofit and 501(c)(3) organization (EIN #88-2401255), and its officers, directors, members, employees, agents, representatives, volunteers, successors, predecessors, and assigns (collectively, "SGI").

1. CONSENT TO PARTICIPATE.

I, _____, the undersigned Parent/Guardian ("I" or "Undersigned") of:

does hereby give my full consent and approval for my Child to participate in all on-campus swimming and water-related activities conducted at the SGI pool ("Pool") or other location on SGI's campus, including recreational swimming and swim lessons, whether offered or made available in connection with my Child's attendance at SGI summer camp, known as "Camp CRIS," participation in camp activities and other events occurring on SGI's campus, or enrollment in swim lessons conducted at the Pool through a third-party provider and qualified instructor ("Instructor"), and/or for any other reason whatsoever. Undersigned acknowledges and understands that all swim lessons conducted at the Pool are offered exclusively through such Instructor on the dates and times provided by the Instructor and made available to Campers and non-Campers ages 4 to 10-years old for an additional cost borne solely by Undersigned and paid directly to such Instructor.

2. ACKNOWLEDGMENT OF RISK.

I understand and acknowledge that my Child's participation in swimming activities and lessons at the Pool involves inherent risks, including but not limited to drowning, slips, falls, and other injuries or accidents that may occur in, on, or around the water. I hereby certify my Child is in good health and has no physical condition or impairment that would prevent safe participation in swimming and other water-related activities.

3. RELEASE OF LIABILITY.

In consideration of my Child attendance at Camp CRIS and/or participation in on-campus swimming activities conducted at the Pool, I hereby release, waive and forever discharge SGI and its owners, officers, directors, employees, agents, representatives, volunteers, successors, predecessors, affiliates, assigns and independent contractors, including the Instructor (collectively, the "Released Parties"), to the fullest extent permitted by law from any and all claims, demands, causes of action, and liability of any kind, known or unknown, for all injuries, accidents, and/or damages arising out of, resulting from, or relating in any way to my Child's participation in swimming and other water-related activities, including recreational swimming and swim lessons, conducted at the Pool or on SGI's campus in connection with my Child's enrollment in swimming lessons through the Instructor, my Child's attendance at Camp CRIS or other events and activities occurring on SGI's campus, and/or for any other reason whatsoever.

4. INDEMNITY AGREEMENT.

Undersigned further agrees to indemnify, defend and hold harmless SGI and its officers, directors, employees, staff, volunteers, representatives, agents, successors, predecessors, affiliates, assigns, and independent contractors, including the Instructor (collectively, "Indemnified Parties"), from and against any and all claims, demands, liability, actions and causes of action for all losses, costs, expenses (including reasonable attorney's' fees), and damages, including without limitation, claims for bodily injury or death, personal, economic, emotional or mental injuries, property damage, and any other compensable damages or losses of whatever kind or nature, known or unknown, arising out of, resulting from, or relating in any way to my Child's participation in swimming and other water-related activities, including recreational swimming and swim lessons, conducted at the Pool or on SGI's campus in connection with my Child's enrollment in swim lessons through the Instructor, my Child's attendance at Camp CRIS or other events and activities occurring on SGI's campus, and/or for any other reason whatsoever, whether such claims are brought by Undersigned, my Child, or a third-party, unless due to the Indemnified Parties' gross negligence or intentional misconduct.

5. EMERGENCY MEDICAL TREATMENT.

Undersigned authorizes SGI and its staff to administer basic first aid to my Child and to seek emergency medical treatment if deemed necessary. Undersigned understands that every effort will be made to contact me in the event of an emergency and agrees to be financially responsible for any medical expenses incurred.

6. PHOTO/VIDEO RELEASE.
